

Sharon Township Board Meeting Minutes

APPROVED

CALL MEETING TO ORDER: The Sharon Township Board held its August board meeting on Thursday, August 1, 2013. ~~Treasurer Simons~~ **Supervisor Psarouthakis** called the meeting to order at 7:00 pm. There were 7 public attendees.

PLEDGE OF ALLEGIANCE: The pledge of allegiance was said.

ROLL CALL: Farmer, Mikel, Psarouthakis, Simons, Hopkins: PRESENT

APPROVAL OF THE AGENDA:

Psarouthakis added locks and keys to supervisors report. Hopkins added an MLB report. CACA report will be done by Psarouthakis. Planning report will be done by Spiegel.

Motion by Mikel to approve the amended agenda as presented, supported by Simons. Motion carried.

APPROVAL OF THE June 27, 2013 MINUTES:

Change "Lewis" to "~~Wilson~~ **Spiegel**" under Planning report.

Motion by Mikel to approve the June 27, 2013 minutes as corrected, supported by Simons. Motion carried.

PUBLIC COMMENT: No comments.

SUPERVISORS REPORT:

Locks and Keys: We are taking steps, hopefully will have new locks next week.

Internet: working on the internet issue since last year. Been in contact with Air Advantage, Representative Driskell connected us with AT&T, currently we have no belief that internet will be coming to our area soon from these companies- we are still working on solutions and contacts

Side note: Rep. Driskell is putting across bills dealing with drilling/fracking, etc. and when the time comes she will be more than willing to come to the town hall to talk to us and answer any questions.

Town Hall: Currently we are dealing with the bat problem, it is not a safe working environment until the bats have been removed and attic space cleaned. Kleinschmidts has been hired to repair a ~~hole~~ **hole** in the roof. We have started talking about possible renovations to the building as it appears the building has not been maintained in the past. We have just started looking into contractors and ideas for renovations.

FINANCIAL REPORT: Simons reported that we are in tax season. In May we made a bond payment and our next payment is due in December.

Motion by Psarouthakis to approve the Financial Report, supported by Mikel. Motion carried.

ZONING REPORT: Administrator, Wilson reported 2 new pole barns and a couple land splits coming up.

PLANNING COMMISSION REPORT: PC commissioner Spiegel reported that they have been working on the “standards for ranch style gate entrances” and will be working on “standards for livestock on smaller acreages”

CHELSEA AREA CONSTRUCTION AGENCY REPORT: Psarouthakis reported that CACA was over budget on workman’s comp and tabled that issue until next month. Quite a few new projects are coming up including Chrysler, Jiffy, CRC, etc. Discussion took place over existing bond money issues and getting the money to the proper holders.

MLB: Hopkins reported that they held their annual meeting and Deeluw is secretary, Dobis is Vice Chair and Hopkins is Chair.

NEW BUSINESS:

- a. Psarouthakis is contacting the Jackson Road Commission to spray Prospect Hill which we have budgeted for.

APPROVE BILLS: Mikel reported that the August bills have not come in yet and presented her June and July bills reports.

Motion by Psarouthakis to approve bills reports as presented, supported by Hopkins. Motion carried.

PUBLIC COMMENT: Concerns about why the road commission worked on Pleasant Lake Rd East of M52 and did nothing West of 52 where more work needs to be done. Psarouthakis will be contacting them. A request was made to have the road commission come out to the town hall and look at some of the residents’ complaints. Psarouthakis encouraged residents to call and e-mail the road commission and voice their complaints/concerns in the meantime.
