

## Sharon Township Board Meeting Minutes

APPROVED

June 24, 2015

**CALL MEETING TO ORDER:** The Sharon Township Board held its regular meeting on June 24, 2015 at the Sharon Town Hall. Supervisor Psarouthakis called the meeting to order at 7:05 pm. There were 4 public attendees. The Pledge of Allegiance was said.

**ROLL CALL:** Farmer, Mikel, Psarouthakis, Simons: PRESENT Spiegel: ABSENT

### APPROVAL OF THE AGENDA:

Motion by Mikel to approve the agenda, supported by Simons. Motion approved.

### APPROVAL OF THE June 4, 2015 MINUTES:

Motion by Simons to approve the minutes, supported by Farmer. Motion carried.

**PUBLIC COMMENT:** A question was asked about who to contact with questions at the road commission and a question on the budget.

### SUPERVISORS REPORT:

Psarouthakis reported that he met with the new Western Washtenaw lieutenant Lisa King. She said the biggest complaint is the lack of information on the sheriff reports and that she will be working on that. Following the recent tornado storms there was a line down on Eausades where the fire department sat until it was taken care of and safe. He also mentioned there will be a public meeting in September at Sharon Mills park to get resident input on a potential Master Plan. Psarouthakis reported that the Manchester school board budget is in bad shape and headed towards possibly using a financial manager.

**FINANCIAL REPORT:** Simons reported that tax bills will be going out the 1<sup>st</sup> of July and the BS&A software update will take place on July 23<sup>rd</sup>.

Motion by Psarouthakis to approve the financial report, supported by Mikel. Motion carried.

**ZONING REPORT:** Administrator, Wilson, reported 4 new compliances (pole barns) and 1 new barking dog complaint on M52.

**PLANNING COMISSION REPORT:** Chair, Bill Lewis, cancelled the June meeting.

**MLB:** There was no MLB meeting.

**CACA:** Farmer reported that CACA held a special meeting to go over 3 resumes. They voted to allow temporary chairperson to make the final decision.

### OLD BUSINESS:

- a. **Adopt the 2015/2016 BUDGET: (The Full resolution can be viewed at the Township Hall)**

**2015 Budget Resolution was offered by Supervisor Peter Psarouthakis, and supported by Clerk Mikel.**

**Roll call vote: Farmer: YES, Mikel: YES, Psarouthakis: YES, Simons: YES. Resolution adopted.**

### NEW BUSINESS:

**a. Amend official township publication to the Sun Times**

Motion by Psarouthakis to make the Sun Times the official publication of Sharon Township, supported by Farmer. Motion approved.

**APPROVE BILLS:** Due to this being the July meeting, held the last week in June, there were no bills in yet and therefore no warrant report.

**PUBLIC COMMENT:** Question about the Eausades Parking lot and it being an “accessory use” to the main use rather than going through the Special Use permit process.
